#### Item 3 Minutes of Previous Meeting

The minutes of the previous meeting were signed by the Chairman, proposed by Cllr Timson and seconded by Cllr Cornelius, agreed by all.

# Item 4 Public Participation

- a) Adrian Urch, South Parade, Chew Magna, addressed the Council regarding not being able to leave a voice message for the Clerk as answering service discontinued and the loose noisy manhole cover in the road by the Pelican Inn, The Clerk will purchase an answer phone machine to replace the BT Call Minder Service subscription. Cllr Montague has reported the manhole cover to B&NES, the Clerk will reiterate and express urgency of repair.
- b) Graham Kelly, General Manager, Boss Developments, addressed the Council regarding Condition 3 Variation on approved planning application for the Madam's Paddock development. Mr Kelly will provide any additional information concerning the fettered and unfettered access to the development. The request is for an easement of vehicles up to 7.5 tonnes to complete the project and from there on, thereby, a fettered limit of vehicle access of 7.5 tonnes.
- c) Ramesh Yadev, Pharmacist, Chew Pharmacy, addressed the Council to thank Councillors and Parishioners for their support in the first week of the opening of Chew Magna Pharmacy and would like to install a hand rail at the end of the steps adjacent to the Moon Dance forecourt to facilitate access to the Pharmacy.

# Item 5 Report back on meetings and progress

a) Boss Development Green Space & Allotment payment to B&NES £19184.84 The Chairman advised that B&NES has received a payment from Boss Developments which Chew Magna Parish Council must apply for to use as benefit to the parish but within the restrictions which apply to green spaces and allotments. The Chairman has requested that ideas for allocation are presented to the Green Space & Allotment Working Group ASAP – the working group will decide on three options to submit to B&NES. The Working Group Committee members are Cllr Nick Scholefield, Vice Chairman, Cllr Paul Cornelius, Cllr

Heather Montague and Cllr Bob Luton. The Vice Chairman will speak with B&NES to ascertain the use of the grant and what would be a viable application. Initial suggestions presented are:

- Chairman Refurbish and improve playground and access
- Cllr Cornelius The creation of a Parish Land Trust to save money for a future recreational field / sporting area / play area / allotment / community area
- Cllr Davis Allotment land
- Cllr Montague Footpath or safe area to walk to playground after response from B&NES to understand if the Governing Council is prepared to finance
- b) Stronger Communities meeting 26<sup>th</sup> February, 1-3pm, Baptist Church, Chew Magna

Cllr Montague attended the meeting, which highlighted support groups available to the community. Cllr Montague will provide the information regarding support groups to Cllr Jerrome to ensure that all information is on the Chew Magna website. The Agents would like a road show to showcase what is available in our area for residents. Ramesh Yadev, Pharmacist, has kindly offered to host the road show in the summer and will work with Denise Perrin, Village Agent Project Manager.

- d) The Vice Chairman and Cllr Andrews attended the Connecting Communities meeting on Thursday 12<sup>th</sup> February that focused on Care in the Community. The Village Agents, Police and Fire Brigade were also represented
- e) Parishes Liaison meeting, Wednesday, 25th February, 2015, 6.30 pm, Keynsham

The Vice Chairman and Cllr Andrews attended the meeting which addressed the implications of the Care Act and the impact on the elderly . The Local Development Framework plans were updated. Cllr Andrews voiced the concerns of Chew Magna Parish Council at the apparent unwillingness of the Chairman of the Development Control Committee to put forward plans, which are considered major within the Parish, for full discussion by the Committee. There would appear to be a lack of appreciation of rural/parish circumstances and communities. There will be a review of the Parish Sweeper Scheme for implementation in 2016, the Parish Council will be consulted. The next meeting will be on 15<sup>th</sup> June 2015.

  The Vice Chairman and Cllr Hasell attended the meeting. The Vice Chairman will submit the Parish's Character Assessment that will be an abridged version of the CA accepted for the Placemaking Plan. The Neighbourhood Plan Survey will be presented to Chew Valley School to collect the views of younger people in the community. The Chairman suggested a cycle way all around the edge of Chew Valley Lake. Next CVNP meeting will be on 23<sup>rd</sup> March

- Connecting Communities Chew Valley Forum Action planning and Your Care, Your Way - comments needed by 24<sup>th</sup> March No comments applicable.
- j) B&NES Council approved the Community Infrastructure Levy Charging Schedule on 17<sup>th</sup> February 2015. The Charging Schedule will take effect from 6<sup>th</sup> April 2015
  - The Chairman read the notice, which has been circulated to all.
- k) Misinformation regarding prescription collection at Chew Pharmacy: The Chairman read a letter printed in the Chew Valley Gazette to Council and thanked Cllr Montague for clarification on the matter of fulfilling prescriptions. The Chairman supports any businesses which will dispense prescriptions in the valley within rules and guidelines. The Chairman and Cllr Montague will write to the NHS Commissioning Trust to
- Cllr Montague reported that concerns of some parishioners had been raised regarding the future of the BT Telephone Exchange. The Parish Council has not received any information regarding this.

## Item 6 Transportation, Highways and Footpaths

clarify the misinformation situation.

a) B3130 Belluton Lane – The Narrows, Chew Magna – Temporary prohibition of use by vehicles notice order from 13<sup>th</sup> March 2015 Ged McGill, MM contractors has confirmed that the Hibernia Fibre Optic installation works in Chew Magna will commence 9th March under 2 way traffic control & full road closures. The work will start from the Winford side of the village at Dark Lane & will progress through the village to link up with the already installed duct at the bend by the cricket ground on Stanton Road. The total duration is forecasted to be between 3-4 weeks maximum, with a hope to complete sooner depending on the ground conditions. To undertake the work at the narrow sections along the road, primarily outside the Co-op & at the Chalks, the road will be closed off entirely with a diversion in place at weekends only to minimise the disruption for businesses & bus operators. The road closures will take place during the weekends 14<sup>th</sup>/15<sup>th</sup> March, 21<sup>st</sup>/22<sup>nd</sup> March & possibly 28<sup>th</sup>/29<sup>th</sup> March.

B&NES advise that weekday bus services will operate as normal and B&NES will be providing a shuttle taxi service to connect with the 672 on the Saturdays to help with Saturday workers and older people who may need to go shopping. Cllr Andrews suggested that more road closure signs will be required at the junction of Lime Burn and Chew Hill and at Portbridge; the Vice Chairman will contact Ged McGill. Cllr Andrews advised that Radio Bristol should be notified of road closures, the Clerk will contact them.

- b) Churchyard steps railing Cllr Hasell has received a request from resident to install a hand rail on the steps to the churchyard. The Chairman believes that the property belongs to the church rather than the Council; however, as the steps are on the highway the Clerk will contact B&NES to request their view.
- c) Recruitment of Speedwatch Volunteers

Cllr Montague reported that speed watch is working well and needs more volunteers for a few hours one or two days a month. The Clerk will advertise on the notice board.

Cllr Andrews reported that the speed sign at Broadcroft is not working; the Clerk will contact B&NES.

- d) Parked cars at entrance off Harford Square Cllr Montague has ascertained that the land is privately owned by Sakina and Roger Buoy and therefore should not be parked on by public vehicles.
- **e)** Questions raised to Cllr Montague regarding possible purchase of land for future car park
  - Ward Cllr Richardson has checked with B&NES and an identified area can be included in the Neighbourhood Plan.
- f) Cllr Cornelius raised the issue of parked cars along Spratts Bridge causing driver visibility problems.
  - The Vice Chairman advised that Spratts Bridge will be resurfaced in the coming financial year's budget and will contact Highways regarding new no parking areas.
- g) Cllr Cornelius requested that B&NES are asked to provide a pavement from the verge at North Chew Farm, Norton Close to the playground for safer access for parents with small children and prams. The Clerk will contact B&NES.

The proposals for extensions and internal modifications to both sides of this listed building are appropriately designed and could update accommodation and enhance the apparent balance and grandeur of the house.

However, Chew Magna Parish Council have concerns that the comparatively modest setting of the house and the proposed hard landscaping would require significant compromises to be made for this application to gain our support.

- 1. The South facing wall and doors of the proposed office extension are set uncomfortably close to the garden terrace wall (approx. 1.5m), giving a somewhat awkward and cramped aspect.
- 2. The proposed West extension (orangery/kitchen) would largely block the southerly street view of the Valley and distant rise towards the Mendips\* that the open garden presently offers. Further obstruction would result from the proposed installation of inappropriate solid timber gates.
- 3. Landscaping work proposes replacement of the entire lawn area to the south west of the garden with stone paving for extra car parking. We are concerned that the extent of the paved area would be inappropriate for the garden of a listed building, prominent on the village High Street.

Furthermore, the plans do not show how the potential effects of increased rainwater run-off from this extensive paved area might be mitigated, and also do not take into account the mature Lime tree (not shown) on the western boundary at the extreme south west of the proposed paved area. Excavation in this vicinity may cause significant damage to the tree roots.

Significant public views out from the village High Street are mentioned as an asset in the adopted SCA (2012)
