Parish Council Airport Association Response to Application 25/P/1505/AOC - Bristol Airport, North Side Road, Felton, Wrington, BS48 3DY

### Request to discharge condition 7 (Construction Environmental Management Plan),

The PCAA objects to the discharge of Condition 7 Construction Environmental Management Plan (CEMP) as the Environmental Protection Team has raised concerns about the fact that a complete CEMP has not been submitted.

It is essential that an acceptable Plan is delivered for this site, given the sensitive nature, rather than just a promised design.

## Request to discharge condition 26 (external lighting design strategy),

The PCAA has no objection to the lighting design strategy as long as it delivers low profile lighting that minimises impact on surrounding residents and local wildlife, in particular the bat population.

### Request to discharge condition 27 (contamination)

The PCAA objects to the discharge of condition 27 (contamination) due to the lack of a complete CEMP and the concerns raised by the Environmental Protection Team.

## Request to discharge condition 28 (remediation scheme)

The PCAA objects to the discharge of condition 28 (remediation scheme) due to the lack of a complete CEMP and the concerns raised by the Environmental Protection Team.

# Request to discharge 31 (Surface Water) in relation to silver zone car park extension (known as Site M, Cogloop 2) on application 18/P/5118/OUT

The PCAA objects to the discharge of Condition 31 as we feel the report submitted does not identify the environmental impact of long term car parking on a greenfield site that was previously used for agricultural purposes, and only approved for temporary use for carparking.

HOPE OR HYPE: CAN SAF REALLY JUSTIFY AIRPORT EXPANSION?

"Sustainable" aviation fuels are often promoted as the answer to aviation's decarbonisation problem, but they are not a magic bullet. Here we summarise 6 reasons why SAF won't be sufficient to mitigate increased emissions from airport expansion.

Government estimates suggest that SAFs can reduce emissions on a lifecycle basis by up to 70% on average. <u>AEF is clear</u> that these emissions savings must be constantly assessed and monitored – not merely assumed.

Sustainable aviation fuel releases the same amount of CO2 as conventional jet fuel (3.16kg CO2 for every kg of fuel)

AFs maybe good in theory, but there are many problems associated with their deployment.
